Message from the President

2015 has been a remarkable year for the International Association of Law Schools with significant milestones and achievements. The Association and its members should be extremely proud. This is the first year of leadership by a new board.

At the start of the year the Association's revised Bylaws were passed with over 95% voting in favor, the two officers were approved by over 96% and the new slate of Governors for the IALS Board passed by over 98%.

We have had four extremely successful regional meetings that laid the foundation for the formulation of the Madrid Protocol, which was formalized at the Global Forum in Madrid. Formulated in Africa, debated in the Americas, crystalized in Europe, and finalized in Asia Pacific, the <u>Madrid Protocol on the Principles of Evaluation of Legal Education</u> is the consensus among law school leaders as to the fundamental principles on how we should be evaluated. The Protocol coupled with the <u>Singapore</u> <u>Declaration on Global Standards and Outcomes of a Legal Education</u> serve as the foundation for further scholarship and consensus in bringing together our worldwide community of legal educators.

I would like to thank all of those who have already renewed their membership for 2016. It's a pleasure to see the loyal support that the Association receives from its valued members. If your school is not a member, we welcome you to join your colleagues in shaping a global perspective for legal education. The IALS is a non-profit, volunteer service organization. It is a learned society of over 170 law schools and departments from over 60 countries representing more than 7,000 law faculty members. A wealth of information is available on our website. Rule of Law, Conflict and Legal Education: The transformational power of quality legal education in Africa

Abstract

The authors of this paper are two law students from strikingly diverse backgrounds, whose stories converge in law school. This paper will analyze the transformative role of quality legal education in the creation of common standards in society, vis-à-vis the rule of law and conflict by looking at the comparative experience of these two authors. It will examine the relevance of legal education to the African society, particularly the transformational role of "quality legal education" as an equalizing factor in the lives of young professional law graduates. Further, it will scrutinize the transformative power that "quality" has in the training of the modern lawyer, and propose quantifiable ways of measuring this "quality education" appropriately.

Introduction

This paper begins with recounts of two stories that interweave, on backgrounds far distinct but proximate enough, to advocate for standards in legal studies in Africa: it brings forwards the perspectives through which legal education should be seen in Africa, particularly in East Africa. We must look at law schools as producers, the society as the consumers, the student as the raw material and the lawyer as the final product offered. (Ibid) The varying quality of student training should be brought about by the diversity of external demands. (The Quality of Legal Education in Russia: Stereotypes and Real Problems The Global Network for Public Interest Law January 2014)

This paper presents the Africa society as the consumer with the unique characteristic of requiring urgent and severe social reconstruction, as it is generally conflict prone. (Institute for Security Study, a think tank based in Nairobi, classified 26 out of the 55 states in Africa as fragile see Jakkie Cilliers and Timothy D Sisk, Assessing State Long-Term State Fragility in Africa: Prospects for 26, More fragile, Countries, ISS Monograph Number 188 [2013] Institute of Security Studies, p.41) There is urgent need for lawyers who have; a deep rooted appreciation for the dignity of the person; understanding and appreciation for various cultural and religious substructures that often create a de facto pluralist legal system; to be, and perhaps with great emphasis, peace brokers and engineers of sustainable unified societies.

This is in addition to the essential but generally applicable criteria of, inter alia, employability, advocacy skills, professionalism, legal ethics and research capabilities.

Apparently, the recounts reveal, the raw material is not standard. The goal is however the same. Nonetheless, a quality legal education can be equalizing factor in producing lawyers who can effectively serve the needs of the society. Thus it proposes targeting value outcomes, such as human dignity and cultural contextualization to enhance the appreciation of the rule of law in societies that are prone to do otherwise and ultimately ensure sustainable peace. The scope can be said to be beyond employability.
