The University Of Namibia Faculty Of Law consists of three departments: Commercial Law; Public Law and Jurisprudence; and Private and Procedural Law. In addition, two Centres fall under the Faculty, viz. the Human Rights and Documentation Centre (HRDC) and the Justice Training Centre (JTC). The Faculty also runs a Legal Aid Clinic, whose mandate includes the provision of clinical legal education to our final year LLB students and the offering of legal assistance to the indigent members of our community. Since its establishment as a fully- fledged faculty of the University in 1992, it has remained the only institution offering legal education to Namibians who would like to receive a locally –based legal education. The UNAM Law faculty welcomes all the Deans from various African law schools who will be attending the 2015 forum to be held at the beautiful seaside resort of Swakopmund. We look forward to exchanging fruitful views with all of you on the very important matters of legal education such as curriculum development and presentation, research and other issues pertinent to the development of legal education and the legal profession in our various jurisdictions.

Far Eastern Federal University, Russia

Host of the 4th Asia-Pacific Law Deans' Forum

The history of FEFU legal education began in 1899 when the first course in Law was introduced into the degree program of the Institute of Oriental Studies. The FEFU School of Law was recognized by the Russian Federal Government as one of the leading law schools of Russia. In 2011, the FEFU law degree program joined the rank of the one of the best innovative educational programs of Russia. It is the only law school in the Asian region of Russia that provides all levels of legal education: Bachelor of Laws, Specialist of Laws (close to J.D. level), Master of Laws, Candidate of Laws, Doctor of Laws and programs for additional vocational training. The school has 95 faculty members, 76% of them with Ph.D. degrees in Law, and over 1,200 students, making the FEFU School of Law one of the largest law schools in Russia. Major areas of interest are Comparative Law of Asia-Pacific Rim Countries and Law of the Sea.



University of Trento, Faculty of Law, Italy

Host of the 4th European Law Deans' Forum

The Faculty of Law of the University of Trento is a small place in the heart of the Alps, where excellence in the fields of research and teaching is developed. Its opportune location—bordering Austria and situated at the core of the EU—facilitates a lively and intimate research environment, and has helped the Faculty develop close connections with the main European Law Schools. The Faculty is facing the challenge and opportunity of expanding its programs by, among other things creating bachelor degrees in Comparative, European and International Legal Studies through classes taught entirely in English). Finally, the Faculty is working hard to become a center of excellence in the fields of study and training on migration, integration and sovereignty.
