## Who We Are

The International Association of Law Schools is a non-political, non-profit, learned society dedicated to serving the worldwide legal education community. It is an association of more than 170 law schools and departments from over 60 countries representing more than 7,500 law faculty members. Our primary mission is the improvement of legal education throughout the world. The idea for an international association of law schools emerged from several meetings of legal educators from around the world who recognized the growing interrelationship of norms from transnational legal systems.

The first such meeting was held in Florence, Italy in the year 2000, and consisted of 50 invited legal educators from 27 countries. This meeting led to additional meetings of international legal educators, and during the May 2004 meeting in Hawaii, 130 legal educators from 47 different countries unanimously adopted a resolution to form the International Association of Law Schools. In May 2005, a select group of legal educators from 14 different countries, representing all types of the world's legal systems, gathered in Istanbul, Turkey, and agreed to the terms of a charter for the International Association of Law Schools. In October 2005, the IALS was incorporated under the laws of the District of Columbia in the United States of America.

Since its transition in 2014 to a new charter and an independent Board of Governors, the Association has embarked upon an ambitious and innovative agenda of developing a global consensus on the fundamental principles, guidelines and outcomes of a legal education. To that end, we have convened over 35 meetings, fora, conferences and workshops to ensure that all voices of our worldwide community of law teachers be heard and respected. These foundational agreements could only have been concluded through such cooperative and consensus-building efforts. These discussions have resulted in the adoption of the Singapore Declaration on Global Standards and Outcomes of a Legal Education, Madrid Protocol on the Principles of Evaluation of a Legal Education, and the Judicial Standards of a Legal Education.

## Where We Meet

Over 50 conferences in the past 7 years alone, in over 30 countries. Annual Meetings in China, Canada, Australia, Germany, Italy, Argentina, India, Spain, United States, Qatar and Poland. Global Law Deans' Forums in Singapore, Spain, India and Poland. Regional Fora in African region – South Africa, Nigeria, Kenya, Namibia, Zambia, Ghana and Rwanda; in the Americas region – United States, Chile, Colombia, Puerto Rico, and the Dominican Republic; in the Asia-Pacific region – Thailand, Vietnam, Malaysia, Russia, Hong Kong, Indonesia, Australia and China; in the European region – Netherlands, Estonia, Ireland, Italy, Poland, Jordan and Spain.

## **Programs**

Our discussions and decisions are informed by the mission and experiences of all our members. These discussions have resulted in the adoption of the following:

### **Evaluation, Assistance, and Certification Program**

 The criteria will be developed from the opinions, concerns, suggestions, and decisions of the membership and EAC Committee. We are committed to ensuring that all viewpoints and perspectives are represented, and that the EAC process is sensitive to the multiple contexts of our members.

#### Foundational Principles:

 Singapore Declaration on Global Standards and Outcomes of a Legal Education

A set of principles that outline global standards and outcomes of a legal education. These principles establish a baseline and a common language for future efforts to improve legal education.

- Madrid Protocol on the Principles of Evaluation of a Legal Education
   A set of principles in the evaluation of legal education
- Judicial Standards for a Legal Education

A set of basic principles promulgated by our Judicial Council in teaching I aw and the foundation of an effective, ethical, and responsible legal education.

### Visiting Professor and Scholar Program

 The visiting faculty member will teach, pursue a collaborative research project with the host institution faculty, participate in workshops and conferences, and prepare a paper on their scholarship. We have expanded the program to include beginning law professors to help advance and support them in their research and teaching skills.

#### **Doctrinal Study Groups**

• The Doctrinal Study Groups focus around the doctrinal interest areas of our faculty members and their scholarship. Currently, these groups are investigating modern pedagogic approaches in educating a new cohort of students to increase student learning and participation; in addition, future work is aimed at enabling faculty to be recognized for their scholarship through peer reviewed publication outlets.



### What We Do

### Regional Law Deans' Fora

There are four Regional Law Deans' Fora: African, Americas, Asia-Pacific, and European. These regional fora adopt a workshop format and concentrate on topics of interest to the leadership of the region's law schools.

#### **Annual Meetings**

The Annual Meeting is IALS' largest event where everyone from each region around the world come together once a year to learn from each other followed with the opportunity to collaborate with colleagues from doctrinal study groups. Within the Annual Meeting plenary session speakers present innovative approaches and thought-provoking papers, which help advance legal education globally. The Annual Meeting is open to all members and non-members.

#### Global Law Deans' Forum

The Global Law Deans' Forum occurs every other year, in which law school leaders from around the world meet to exchange ideas in relation to the region they teach. It serves to distill and focus regional-global perspectives on legal education.
