

SLS, Pune endeavors to secure all-round contribution for the betterment of the field of Law, to create world-class professionals, to produce committed academicians and law reformers, to train justice dispensers and invigorate community crusaders and, to create a strong watershed of new and upcoming expertise in law relating to business and corporate matters. Pune has been ranked 5th in 2024 by National Institution Ranking Framework (NIRF) by Ministry of Human Resource Development, Government of India.

SLS, Pune has been ranked 1st by GHRDC and IIRF and 5th by NIRF in 2024. Since 2007, SLS, Pune has consistently been ranked top 10 amongst more than 1000 Law Schools in India by the India Today-Nielsen survey. This stature is attained through various programmes such as 5-year integrated BA. LL.B. (Hons.)/ BBA. LL.B. Hons., 3-year LL.B. and One-year LL.M with 9 specializations. # ABOUT SCALSAR-FACULTY OF LAW

Faculty of Law, SIU has established Symbiosis Centre for Advanced Legal Studies and Research (SCALSAR). It is the centre-stage for research, quality publications, government interface, host scholars in residence, undertakes interdisciplinary legal studies and research projects, training teachers and designing training modules.

It has 3 research clusters: Science Technology Innovation Law, Rule of Law in Context and Comparative Law. Every year SCALSAR organizes an International Research Conference which has become popular as SYMROLIC representing Rule of Law with Indian and Global perspectives, aligning it with the SIU's vision of an interdisciplinary conference and connecting to different fields such as that of Innovation, Science, Technology, Human Behaviour, Global Policy and Governance. The purpose of SCALSAR under the Faculty of Law SIU, Symbiosis Law School Pune is to centre-stage research, encourage quality publications, act as think-tank to government, host scholars in residence, undertake interdisciplinary legal studies and research projects, training teachers and designing training modules. SCALSAR contributes under three verticals viz. Science technology and Innovation Law, Rule of Law in Context and Comparative Law.

SLS Pune has showcased a strong research culture along with an internationalization agenda that has resulted in successful project applications under the Erasmus + program of the EU. SLS, Pune had the unique distinction of being the only Indian partner with the Erasmus Mundus Global Consortium of Law Schools since 2008. SLS, Pune has been the recipient of four Erasmus+ CBHE KA2 under EU projects namely EURASIA, 21 Teach Skills Training, Climate Change Policy and Law, and International Law and Forced Migration Studies. SLS Pune is also the proud recipient of the SPARC Project 'Legal and Ethical Framework for the use of Artificial Intelligence in Healthcare Sector with special reference to Patient Safety' to develop a legal and ethical framework for AI in healthcare. The project is funded by the Ministry of Education, Government of India. SLS Pune. SLS Pune is also engaged on a Joint DAAD-Project: funded by DAAD on the "Implementation of the SDGs – A Comparative Approach in India, Nepal and Germany." As of now, SLS Pune has received a total of 4,82,379 Euros as grant money for international projects and Rs 97,32,315 for national projects.

SCALSAR has also a rich history of producing groundbreaking scholarly works on law and interdisciplinary areas. In 2024 SCALSAR published more than 98 research papers in SCOPUS and WoS indexed journals by the SLS Pune faculty members and some PG / Ph.D. students, taking the overall publications to 751.

# ABOUT THE CONFERENCE

Symbiosis Conference on "Rule of Law in Context Rule of Law: Just World Order, Digital Life, AI, and Emerging Technologies" (SYMROLIC-25) is an interdisciplinary conference on the repercussion of AI, Digital Life, and Emerging Technologies to the ideals of a just world order and the rule of law. SYMROLIC's journey began as a national conference showcasing in-house research, building on research excellence within and as an avenue for developing new ideas as well as updating research ideas with skills in 2012. It grew into international participation by 2015. This has been drawing on Symbiosis International (Deemed University)'s new impetus to thrust areas, excellence centres and innovation. The conference will be held over two days and is specially designed to discuss and deliberate on various interdisciplinary areas and core issues and suggest a way forward to upholding the Rule of Law.

SYMROLIC-25 continues our rich tradition of generating research-based ideas in our pursuit of academic excellence. A special feature of the conference will be the Plenary Session, which will focus on the repercussions of AI, Digital Life, and Emerging Technologies on the ideals of a just world order and the rule of law. Digital life and AI and emerging technologies refer to the increasingly interconnected world where our daily lives are influenced by artificial intelligence (AI) and other rapidly developing technologies, such as the Internet of Things (IoT), blockchain, augmented reality (AR), and machine learning, which are shaping how we interact with information, devices, and services around us. This year's international conference is expected to generate 75-100 papers in different areas relating to the theme of the conference. In keeping with the goals of the Conference, the plenary session has been conceived as a meeting point for scholars and experts to discuss the issues and controversies surrounding AI and emerging technologies. The plenary is also expected to generate a robust intellectual corpus for channelling the benefits of AI and emerging technologies in our pursuit of a just world order. The Plenary Session will be addressed by eminent scholars like Prof (Dr.) Ketan Kotecha, Head, SCAAI, Prof (Dr.) Subhojit Basu, Leeds Univesrity. We are also expecting Prof (Dr.) Siobhan Mullally, University of Galway and Prof (Dr.) Patricia O Solluvan, University of California San Fransisco to address the gathering at the Plenary Session.

# RULE OF LAW IN CONTEXT: JUST WORLD ORDER, DIGITAL LIFE, AI AND EMERGING TECHNOLOGIES

Rule of Law is a foundational principle of a democracy that establishes accountability and fairness of legal frameworks. It creates an assurance against arbitrary usage of power, and is a cornerstone of democracy. It promotes transparency and public assent to promulgating legal power, which is an indispensable characteristic, especially in the contemporary digital age. The focus of this theme is mainly within the context of technological advancements, with the advent of various innovations in the field. These emergences have created the requirements for more exhaustive and dynamic legal frameworks that accurately reflect the scope of the digital world. With more digitalisation, there have been more challenges that pre-existing legislations and policies cannot properly resolve and address due to insufficiency.

The conference aims to explore and address the gap between the current legal framework and the ideal legal responses needed to regulate emerging technologies. Another key aspect of this theme is ensuring that these regulations align with the principles of the Rule of Law, maintaining justice, accountability, and fairness.

As technologies such as Artificial Intelligence, Blockchain, and Biotechnology continue to evolve, legal systems must adapt to govern them effectively. The various tracks of this conference will explore different aspects of this issue, both on a global and domestic scale.

SYMROLIC aims to bring together faculty members, researchers, doctoral scholars, and students to engage in meaningful discussions on strengthening the Rule of Law in the digital age. Through insightful dialogue and analysis, the conference seeks to contribute to the ongoing development of legal frameworks that can effectively address the challenges posed by technological advancements.

Eminent international scholars like Prof (Dr.) Martin Haug from University of Galway, Professor Martin Faix from Palacky University in Olomouc, Professor Ratna Kapoor from Queens Mary Unvuer, Prof Subhajit Chatterjee from University of Leeds have agreed in principle to officiate the different tracks under the conference and also evaluate the papers submitted.

Citation/ Reference Style - APA style

One inch margin on all sides in all pages.

Correct punctuation, spelling and grammar

Maximum 20 pages (5000-8000 words including references) (A4 size).

While submitting the full paper, the participants must submit the report containing 'No Use of AI' and Plagiarism Report' (upto 10%).

Co-authorship of up to two authors is permitted. However, each coauthor has to individually register himself/herself for the Conference and at least one of the co-authors should be physically available to present the paper.
